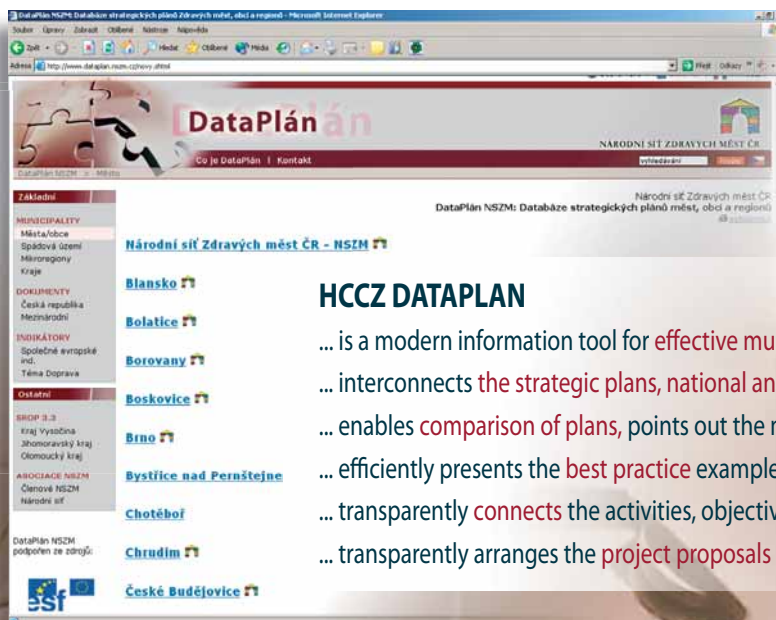

The DataPlan of the Healthy Cities of the Czech Republic (HCCZ) should serve to municipalities, cities and regions for transparent and efficient process management within the framework of municipal administration and for improvement of the overall management at the municipality level.

The Network of Healthy Cities, Municipalities and Regions is an internationally certified organisation covering municipalities that realise pan-European programmes "The Healthy City Project" and "Local Agenda 21". These municipalities systematically support the quality of public administration with respect to sustainable development and health support. For this reason the association focuses in the long-term perspective at the area of strategic management. The new information system **HCCZ DataPlan** is a tool for improvement of management processes in towns, municipalities and regions. The HCCZ DataPlan serves them as a data base environment in which it is possible to work transparently with all strategic documentation of individual cities, municipalities and regions.

From the technical point of view the HCCZ DataPlan is a very transparent, intuitive and congenial web interface. However, inside it is a fairly complex system of data bases that interconnect various types of strategic documents and current activities under way.

- The HCCZ DataPlan pursues the **conceptual and "STRATEGIC DOCUMENTS"** at the municipality level – this deals mostly with the strategic development plan and conception as such as well as other development programmes (e.g. the Programme of Regional Development), but also the community strategic plans, monitoring the public opinion (e.g. the community Health and Quality of Life Plan). The information system also covers the documents of both the national and international importance. Besides this complex issue the HCCZ DataPlan enables working also with partial concepts and expert evaluations.
- Owing to the special functions of HCCZ DataPlan the municipality has available a **transparent "COMPARISON"** of its strategic documentation (expert and community plans) with other cities, it checks its project capacity for solving of various problems and ascertains relations of objectives and activities at the local level with regional and in the future with national and international documents. The CZ and EU Sustainable development strategy, Agenda 21, and others).
- HCCZ DataPlan contains the best activities realised in the municipalities, cities and regions. The overview of **examples of "BEST PRACTICE"** contains innovative and inspirative programmes or activities. It enables sharing of good solutions to various problems encountered by the municipalities in its everyday practice and at the same time it enables comparing them by way of benchmarking. In the final form in section **"BUDGETS"** it is possible to monitor very transparently as how much **financial means** is spent at individual activities and whether these finances are utilised efficiently.
- The HCCZ DataPlan can be utilised for monitoring of realisation of individual projects and measures on basis of specified **"INDICATORS"**, and obtain thus an overview of activities in the given municipality, the costs and the results being brought.
- The HCCZ DataPlan serves as a **"PROJECT STORAGE"** and it can be used effectively e.g. for monitoring the absorption project capacity of cities, micro-regions, regions but also of local action groups etc.
